Eligibility: General seats are meant for bonafide/ domicile residents of Himachal Pradesh and shall be filled on the basis of merit of the qualifying degree plus written test to be conducted by this University on 6th July, 2014 i.e., on the basis of combined merit of written test plus OGPA/ percentage of marks obtained in the qualifying degree on 50 : 50 basis.

Self-financing seats are open for all at National Level and shall be filled on the basis of merit of the qualifying degree plus written test to be conducted by this University on 6th July, 2014 i.e., on the basis of combined merit of written test plus OGPA/ percentage of marks obtained in the qualifying degree on 50 : 50 basis.

Minimum Qualification: B Sc Horticulture/ B Sc Forestry/ B Sc Agriculture/ B Sc Agri Engineering/ B V Sc/ Graduate in other allied fields with an OGPA of 5.50/10.0 (5.00/10.0 in case of SC/ ST category candidates) or its equivalent under course credit system or with a minimum of 55% marks (50% marks in case of SC/ ST category candidates) under annual system from a recognized University or degree from a foreign University with atleast 'B' grade or its equivalent.

Eligibility: The general seats are meant for bonafide/ domicile resident of Himachal Pradesh and shall be filled on the basis of HP-CMAT conducted by the IMS, HPU, Shimla on 24th May, 2014.

Self-financing seats are open for all at National Level and shall be filled on the basis of HP-CMAT conducted by the IMS, HPU, Shimla on 24th May, 2014 or MAT conducted by AIMA, New Delhi on 4th May, 2014. Based on the performance in the respective written tests, candidates would be shortlisted for Group Discussion (GD) and Personal Interview (PI) to be conducted by this University on 15th July & 16th July, 2014 at its main campus.

Minimum Qualification: Graduate in any discipline with a minimum of 55% marks (50% marks in case of SC/ ST category candidates) under annual system or with an OGPA of 5.50/10.00 (5.00/10.0 in case of SC/ ST category candidates) or its equivalent under course credit system from a recognized University or degree from a foreign University with atleast 'B' grade or its equivalent.

Eligibility: 75% of the total general seats are meant for the bonafide/domicile residents of Himachal Pradesh and shall be filled on the basis of HP-CMAT conducted by the IMS, HPU, Shimla on 24th May, 2014. The remaining 25% of the total seats are, however, open for all and candidates applying against these seats shall be required to appear in the MAT examination conducted by AIMA, New Delhi on 4th May, 2014.

Self-financing seats shall be open for all and shall be filled on the basis of HP-CMAT conducted by the IMS-HPU, Shimla on 24th May, 2014 or MAT conducted by AIMA, New Delhi on 4th May, 2014.
