Chapter 3: Guidelines (Terms & conditions)

1. Procedure for Submission of Bids

- 1.1 It is proposed to have a Two Cover System for this tender
 - a) Technical Bid cover.
 - b) Price Bid cover.
- 1.2 Technical Bid of the tender should be covered in a separate sealed cover super scribing the wordings "Technical Bid for LAN / CCTV". Please Note that Prices Should Not be indicated in the Technical Bid at all. If price details found in Technical Bid the supplier is rejected from the Tender.
- 1.3 Price Bid of the tender should be covered in a separate sealed cover super scribing the wordings "Price Bid for LAN / CCTV".
- 1.4 Both the Technical Bid cover and Price Bid Cover, prepared as above, are to be kept in a single sealed cover super scribed with "Tender: RATE CONTRACT of LAN and CCTV, 2014-15".
- 1.5 The cover thus prepared should also indicate clearly the name and address of the parties, to enable the Bid to be returned unopened in case it is declared "Late".

2. Amendment of tender document

- 2.1 At any time prior to the last date for receipt of bids, the Purchaser, may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective party, modify the tender document by an amendment.
- 2.2 The amendment will be notified through website (www.nau.in) to all prospective parties who have purchased the tender document and will be bidding on them. So all the bidders are requested to frequently visit the Navsari Agricultural University website.
- 2.3 In order to afford prospective parties reasonable time in which to take the amendment into account in preparing their bids, the Purchaser may, at its discretion, extend the last date for the receipt of Bids.

3. Documents Comprising the Bids

3.1 Technical Bid Document and Price Bid Document formats are given in the tender documents. Bidder must follow the formats while participating in the tender.

4. Bid Prices

4.1 Price bid of those tender will be only opened whose technical bid is accepted.

5. Selection of Bidders

5.1 Selection of bidders will be done on the basis of the overall grand total obtained for the whole tender.

6. Warranty

6.1 The parties should warrants that the Goods supplied under this tender are new, unused, of the most recent or current models and those they incorporate all recent improvements in design and materials unless provided otherwise in the tender. This warranty shall remain valid for a period of a minimum 12 months after the Goods or any portion thereof as the case may be, have been delivered, commissioned and accepted at the final destination.

- 6.2 The Purchaser shall promptly notify the party in writing of any claims arising under this warranty.
- 6.3 Upon receipt of such notice, the party shall, within 48 hours and with all reasonable speed, repair or replace the defective Goods or parts thereof, without cost to the Purchaser.
- 6.4 If the Supplier, having been notified, fails to remedy the defect(s) within the period specified in 6.3 above, the Purchaser may proceed to take such remedial action as may be necessary, at the party's risk and expense and without prejudice to any other rights which the Purchaser may have against the Supplier under the Contract.

7 Taxes and Other Charges

- 7.1 The successful party shall be entirely responsible for all taxes, duties, license fees, demurrage charges etc., in respect of this contract and provisions of Income tax Act regarding deduction of tax at source shall apply.
- 7.2 Travel expenditures of man power for installation and maintenance during warranty period will not given by Navsari Agricultural University.

8 Terms of Payment

- 8.1 The Bidder should specifically note that no advance payment will be made.
- 8.2 The payment of all charges (hardware, connectivity, services, etc.) shall be made after satisfactory completion of the work as specified.

9 Rights

9.1 Right is reserved to accept or reject any or all tender without assigning any reasons thereof.

10 Security deposit

10.1 EMD of successful bidder will be converted to security deposit.

11 Visit

- 11.1 Successful bidders have to visit every month at installed site(s) as part of Free AMC for 1 year starting from installation date without extra payment.
- 11.2 Every month Successful bidders has to submit performance report of working LAN / CCTV Camera.
- 11.3 If Successful bidders is failing to visit 12 times in a year the security deposit of the bidder will be forfeited and bidder will be declared as a black listed.
