

Appendix A

REGULATIONS FOR THE ADMISSION FROM DIPLOMA COURSE TO BACHELOR'S DEGREE COURSES IN AGRICULTURAL UNIVERSITIES OF GUJARAT

Preamble

The GAU bifurgated into four agricultural universities in the year 2004 under Gujarat Agricultural Universities Act, 2004. The two years diploma courses were reconstructed and started as the polytechnic diploma programme running into six semesters of three years courses in English medium. Diploma courses in Agriculture, Horticulture. Agricultural Engineering, Home Science and Agro-Processing etc. are run by the Agricultural Universities of Gujarat. The SAUs thought to start D to D programme in all the faculties of SAUs vide Notification No. 7.6.1.14 dated 11-03-2011 on the pattern of D to D programme in Engineering colleges of traditional universities. Hence, there is a need to frame out the rules and regulation for admission from qualifying Diploma Examination to degree courses in respective faculties.

- 1. Short title and commencement
 - i) The rules may be called the regulations for admission from Diploma courses to Bachelor's Degree courses in Agricultural Universities of Gujarat.
 - ii) They shall come into force from the academic Year 2015-16.
- 2. Eligibility for Common Entrance Test Examination

For the purpose of admission, category wise minimum OGPA which a candidate shall have obtained in the qualifying diploma examination shall be as under.

3. Admissions to bachelor's degree courses

The admission to the Second Year (Third Semester) of the Bachelor's degree courses on all the supernumerary seats shall be given on the basis of ment list prepared by the admission committee, formed for the purpose considering the weightage of 60 % from OGPA of qualifying diploma examination and 40 % of written test (Common entrance test – CET). The CET is compulsory for seeking admission under D to D programme of the University. The written test will be arranged by the concerned Registrar of the respective university as the place or location decided by the admission committee. The admission will be given as per the aggregate marks of OPGA and Common Entrance Test (CET) examination.

The Central admission committee shall consist of;

- 1) Registrars of SAUs
- 2) Deans of colleges of SAUs
- 3) Member Secretary of the Council of State Agricultural Universities or a representative of the State Council as nominated by Member Secretary.

The Committee is to carry out the admission process in a fair and transparent manner. The admission process is conducted by this Committee strictly on the basis of merit and the preference of the candidate.

The functions of the Committee are as follows:

- The Committee shall supervise, monitor and control the entire process of admission to the candidates seeking admissions to all under graduate degree programmes through D to D programme.
- 2) The Committee shall prepare the ment list in accordance with the provisions of the acts and the rules made there under.
- 3) The Committee shall allocate the available seats in accordance with the provisions of the acts and the rules made there under.
- 4) The Committee shall ensure that admissions on the available seats as per the ment list prepared.
- 5) The Committee shall perform such other functions as may be assigned to it by the council and Government.

4. Seats available for admission

For the purpose of admission, available seats shall include

- Ten seats for the colleges of having intake capacity 100 and above while five seats for intake capacity less than 100 in previous academic year of concerned Bachelor's Degree course(s) in the colleges of Agricultural Universities of Gujarat (Annexure-I).
- 5. Eligibility for admission
 - i) For the purpose of admission, candidate shall have passed the qualifying diploma examination from State Agricultural Universities (SAUs) of Gujarat with minimum OGPA as prescribed in Rule 5.
 - ii) A candidate who has secured admission under these rules in any year shall not be eligible for further admission to any course until the period within which he/she might have completed the course in which he has secured admission.
 - The eligible candidates shall have to apply in prescribed application form and submit with attested documents/ testimonials in stipulated time limit to the competent authority or the centres decided as per the instructions given in the advertisement issued by the competent authority on approval of the Nodal Officer (Education).
 - iv) The application should be routed from the polytechnic where he/she completed polytechnic course
 - 6. Degree course in which admission may be granted

Subject to the fulfillment of eligibility criteria and such other conditions as prescribed under these rules, a candidate who has passed the qualifying diploma examination as shown in column 2 of Annexure I, shall be eligible for admission to the courses as shown against it in column 3 of the Annexure I.

Candidate must pass the common entrance test (CET) with 40% marks.

The written test (CET) guidelines The common entrance test will be of 100 marks having multiple choice questions and syllabus for the CET will be of the courses studied under concerned diploma programme. The duration of the test shall be of 90 minutes.

Candidate must fall above the cut of list of the aggregate merit list as and when prepared during the admission process in the respective faculty subject to the available seats decided by the SAUs in the respective category from time to time.

7. Reservation

7.A The seats available for the Gujarat State candidates shall be reserved as under

7.B General Conditions Regarding Reservation

The reservation of seats for the various categories of candidates shall be subject to following conditions.

- 1. No candidate availing any of reserved seats shown under Rule 7.A or enjoying any concessions in admission requirements shall, however, be eligible to get more than one advantage of relaxation in minimum qualification at the same time.
- 2. In the event of some or all reserved seats specified under rule 7. A remaining vacant due to less number of applications or eligible candidates, they shall be considered as open seats and shall be filled in, in order of merit from the general merit list of candidates.

7 (C) Reservation of seats

Seats are reserved as per Gujarat Government reservation policy from time to time.

- 7.C.1. Candidates fall under reserve categories secure admission on merit of open category shall not, however, be counted against the seat reserved for them.
- 7.C.2 On account of vacant seats due to less number of candidates in one group and/or shortage of seats due to more number of candidates in the other group, reciprocal adjustment will be made in the reserve seats of SC/ST category only.
- 7.C.3 If candidates are more than the reserved seats earmarked for them in the respective category, admission will be given to them strictly on ment basis of the respective category.
- An admission of a candidate of a reserved category shall be valid subject to the verification of cast certificate/s issued by the competent authority. In case the caste certificate is found invalid during admission process or at later stage, his/her admission on reserved seat shall be cancelled. Any candidate who is found to have given any particulars which are false or has suppressed information will be disqualified and, if admitted, will be dismissed immediately and fees will be forfeited.
- 7.C.5 The candidate/s belonging to SEBC shall have to produce the certificate issued from the competent authority showing that he/she does not belongs to creamy layer sections of the society. Such certificate should be of the current fiscal year, otherwise he will not be considered under the SEBC category.
 - 7.C.6 Three percent seats are reserved for the disabled (physically challenged) candidates of Gujarat State which are adjustable within the respective category and subject to the following conditions
 - i) The reservation will be given to the physically handicapped candidates as per the disability Act of the government subject to the production of

- necessary certificates of Civil Surgeon/Medical Superintendent of the Government Hospital
- Disabled (physically challenged) candidate shall have to fulfill the academic and minimum requirements of marks at the qualifying examination of his category as mentioned in Rule-2.
- (iii) The admission of a student of a reserved category on a reserved seat shall be valid subject to the verification of certificate by the authority empowered in this behalf. In case the certificate is found invalid on verification, he/she shall not have right to claim his admission on reserved seat and if he/she has been already granted admission, such admission shall be cancelled at any point of time.
- 7.C.7 An admission of a candidate of a reserved category shall have to produce necessary certificate/s issued by the competent authority.
- 7.C.8 Candidate(s) including reserve category shall have no right for admission unless he/she pass required qualifying diploma examination(s) and appearing in the CET and pass Common Entrance Test (CET) and fall under the cut of merit list of the concerned category and subject as and when prepared in process of admission to the number of available seats as decided by the university. This will apply to all the faculties.

8. Application for admission

- i) The advertisement shall be given in news paper as decided by the competent authority. Any change or corrigendum if any will be uploaded on the website of SAUs of Gujarat only.
- ii) For the purpose of admission, a candidate shall apply, within the time limit specified by the admission committee, in the prescribed form.
- iii) the application form for admission can be obtained from the centers as a same as the center of prescribed from the centers as fees as decided by the admission committee from time to time.
- iv) Candidate has to apply separately for each degree course for which he/she is eligible for admission.

v) The application form duly filled in, shall be submitted by the candidate at the notified centers referred to in rule (4) along with the self attested copies of the certificates and testimonials as specified in the application form.

9. Admission procedure

- (i) All the applications duly received shall be scrutinized by the scrutiny committee in accordance with the provisions of these rules and prepare a list of eligible candidates in the respective category for appearing in the CET. The scrutiny committee consist of;
 - (1) Principal/Associate Professor/Officer on Special Duty of the concerned Polytechnic as nominated by the Registrar of the concerned University (Chairman)
 - (2) Academic in-charge from one college of concerned faculty as nominated by the Registrar. (Member)
 - (3) One Assistant Professor from the college of the concerned faculty as nominated by the Registrar. (Member)
 - (4) Assistant Registrar (Academic) (Member Secretary)
 - (ii) The written test will be conducted at one of the colleges where general admission merit list shall be displayed, on the notice board of the Universities and on their official web-site and by such other means, as the admission committee may consider convenient. The Registrar (Academic) shall prepare a merit list as per the Rule 3.
 - (iii) The candidate whose name appears in the merit list shall have to remain present personally for counseling for the purpose of admission at the scheduled date, time and place.
 - (iv) In case the candidate is unable to remain present personally, on the date, time and place of counseling, due to serious illness, accident or unavoidable circumstances, his parents or guardian shall, after obtaining prior approval of the Nodal Officer (Education) shall remain present on his behalf, along with the documentary evidence showing reason for the absence or inability to remain present personally.

- (v) After getting admission the candidate shall, within a period of seven working days or as specified at the time of admission, report to his respective college or institution. In case the candidate fails to get himself registered, within the time limit the admission granted shall be treated as cancelled.
- (vi) In case the candidate fails to get himself registered, within the time limit due to unavoidable circumstances, may obtain provisional registration by paying fee and complete other requirements within one week or as specified at the time of admission.
- 10.0 Preparation of ment list
 - 10.1 The ment list of the candiataes will be prepared on the basis of OGPA obtained in the qualifying diploma examination and common entrance test (CET) by the university as per Rule 3.
 - 10.2 The criteria for deciding merit order in case of students having equal merit marks shall be in the following sequence, namely-
 - (1) Candidate having higher OGPA in concerned diploma course
 - (2) Candidate having higher GPA during last semester of the concerned diploma course.
 - (3) Candidate having higher % at SSC (10th) Examination.
 - (4) Candidate having Higher age as per eligibility.
- **31.0** Fees

A candidate who gets admission shall, at the time of admission, pay such fees and deposits as may be applicable to the respective degree course by the university from time to time.

12.0 Change of course or transfer

Under any circumstances, after registration, candidate shall not be allowed to change the course, or the college or the university.

- 13.0 Requirement of documents to be attached with the application
 - i) The candidate shall attached the self-attested copies of the following documents with the application form namely
 - a) Qualifying examination of diploma mark sheet / transcript and diploma certificate/provisional certificate
 - b) SSCE. (10th Pass) mark sheet
 - c) School leaving certificate
 - d) Cast certificate (SC/ST) and (SEBC certificate along with non creamy layer certificate of the current fiscal year issued by the competent authority) or any other required certificate/s as the case may be.
 - e) Three recent Passport size photograph (printed name and date),
 - ii) The candidate shall have to produce all original certificate/s and testimonial/s for verification, at the time of counseling.
 - iii) Affidavit regarding anti-ragging discloser

14.0 Interpretation

These rules are made only for the admission for Diploma Courses to Bachelor's Degree courses in Agricultural Universities of Gujarat.

Except these rules, all other relevant existing rules for graduate degree programmes in Agricultural universities of Gujarat are applicable.

In interpretation of the provisions of these rules, if any difficulty or question arises during the implementation or execution of any provision, the decision of the Nodal Officer (Education) of the State Agricultural Universities shall be final.

15.0 Amendment to the regulation

This regulation is based on the regulations in this regard framed by the ICAR, New Delhi under minimum standard of education and any amendments which may be made by the said council from time to time shall be incorporated in this regulation.

16.0 Repeal and saving

The regulations, for the award of Under Graduates degrees as amended from time to time and in existence on the date on which this regulation comes into force, are hereby reposled.
