Regulations for awarding Dr Jayantilal V Majmudar Gold Medal to the student of N M College of Agriculture for securing highest OGPA in Plant Breeding subjects of the B.Sc. (Hons) Agriculture.	
1.	The regulations for the award of Dr Jayantilal V Majmudar Award are framed under Statute -38 of the Navsari Agricultural University.
2.	The award will be known as Dr Jayantilal V Majmudar Gold Medal.
3.	The Gold/Coin Medal shall be prepared in the limit of interest earn from Rs. 3 Lac deposited by the Donor. It shall be prepared by engraved with the words " Dr Jayantilal V Majmudar Gold Medal"
4.	The medal shall be awarded to the B.Sc. (Hons) Agriculture student of N M College of Agriculture for securing highest marks/OGPA in Plant Breeding subjects offered during B. Sc. (Hons) Agriculture programme. The student/ candidate having minimum 7.0 out of 10 OGPA will be eligible.
5.	In case of tie, the candidate having highest Overall Grade Point Average OGPA at the end of degree programme shall be considered to select the awardee.
6.	A committee consisting of (a) Dean, Agriculture Faculty, (b) The Director of Students' Welfare, (c)The Registrar and (d) One expert nominated by Hon. Vice Chancellor shall decide the awardee.
7.	The Medal shall be awarded to a student on the occasion of Annual Convocation each year.
8.	A student who secures 'F' (Fail) or 'US' or 'I' grade at any time in any subject or has at any time dropped (barring withdrawal) the course as a regular student shall not be eligible for the award.
9.	The students who have received CP (Conduct Probation) at any stage of entire programme shall not be eligible for the award.
10.	The donor of the award shall be invited and acknowledged appropriately in the award function.
11.	The decision of the Board of management in this regards shall be final.
