#### Terms and Conditions of the Tender for rate contract, 2017-18

- 01. Bids are invited from the **manufacturer/authorized** dealers only in terms of discount on original price of various brands of Plastic wares (as per Chapter 3: List of brands) along with duly furnished information, tender fee and EMD/security deposit.
- 02. The bidder must submit the **Non-refundable** tender fees of **Rs. 1500** and **refundable** earnest money deposit/Security deposit of **Rs. 25,000.** Tender Fee and EMD must be in favour of "Navsari Agricultural University Fund Account" drawn on State Bank of India, Navsari [Branch Code No. 3889].
- O3. Bids once quoted can't be change throughout the period of Rate Contract. The finalized price will be valid for the entire period of rate contract *i.e.* up to 31-12-2018 and F.O.R. at Navsari and sub centers (Appendix-IV) of Navsari Agricultural University.
- 04. In case of authorized dealers, bids will be considered when they provide a letter of original authorization (not photocopy) from the manufacturer issued after the date of publication of this advertisement in favour of "The Principal and Chairman RC Committee, N.M. College of Agriculture, Navsari Agricultural University, Navsari". Also, authorized dealer (bidder) must have to provide company details as per Appendix-II.
- 05. The bids quoted by Sub-dealer will not be considered in any circumstances.
- 06. Bidder has to submit the tender documents online as well as in hard copy as per the checklist (Appendix-I).
- 07. Upload the original price list of plastic wares only provided by the manufacturer and duly certified by the bidder for its authenticity (**As per Appendix-III**). Price list for respective brands along with GST rate will be preferred.
- 08. The bidder should ensure that duly furnished hard copy as per checklist (Appendix I) must reach to the office of **The Principal and Chairman RC Committee, N.M.**College of Agriculture, Navsari Agricultural University, Navsari 396 450 (Gujarat) on or before 17/11/2017, 17.00 hrs. Envelop should be marked as "Rate Contract, NAU/ DR/ Rate Contract/PW/2017-18 for Plastic wares".
- 09. While uploading the tender document particularly pricelist, if the file size is more than admissible size (i.e. < 3 MB). Bidder must fragment the file with appropriate freeware software and then upload. If fragmented files were not reassembled in original format, bidder will be responsible for the same. It is advisable to test multiple time fragmentation and reassessment process at bidders end. Bidder has to provide the software detail and downloading path in separate text file while processing fragmentation.
- 10. The GST charges are applicable on the price after discount as per the Government rules. No other charges will be acceptable.
- 11. The supply must be within the delivery period mentioned in the purchase order; otherwise the order will be automatically cancelled. If any technical reason for delay, consent of orderer is required.
- 12. The advance payment will not be made under any circumstances. Further, the payment of the supplies will be made after execution of the complete order.
- 13. TDS on bill amount will be deducted as per government rules.
- 14. There should be no discrepancy in price quoted under current Rate Contract for the similar supplies at all the SAUs of Gujarat.
- 15. The approved suppliers are responsible for the quality of the supplies, any deviation in quality of supplies such as short expiry, purity *etc*. liable to cancel the order.

After finalization of rate contract, party is bound to supply any single item or all items given in the price list. Inability for the supply of goods within the stipulated period and as per the specification by the party after placement of an order will lead to forfeiture of tender deposit. Penalty or penal interest will not be paid due to delay in payment on account of 17. unavoidable circumstances. The right to accept or partially accept or to reject the offer is reserved, and cannot be 18. challenged. Once offer rejected, there will not be any kind of reconsideration for inclusion in the rate contract. 19. All necessary documents will be provided for exemption of Custom / Excise duty. Suppliers will have to follow the required procedure for getting exemption of Custom / Excise duty. The demurrage charges will not be paid in any circumstances by the university. 20. In case of any dispute, decision of The Purchase committee, Navsari Agricultural University, Navsari shall stand final. 21. The jurisdiction for any legal dispute shall be Navsari District court only. Before submitting the application, manufacturer/authorized dealer has to solve the 22. territory problems. After submission of the application, such problem will not be entertained by NAU. 23. If any of the required information is missing, the bid will be rejected straight away. If any kind of malpractice found regarding the details submitted by the bidder at any stage of procedure, then the bid will be immediately rejected and the party will be blacklisted for future endeavours. 24. Amendment of bidding documents (corrigendum), at any time prior to the deadline for submission of bids, NAU may, for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents. The corrigendum will be published only on following on website http://www.nau.in and www.nprocure.com only. In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids, at its discretion, NAU may extend the deadline for the submission of bids.
