3. Delivery period should be not more than 7 days after getting the firm order and the party should have to supply **F.O.R.** at Main Cotton Research Station, NAU, Surat inclusive of all taxes, which should be mentioned in the quotation.
4. No advance payment will be given. The final payment will be through account payee cheque only and no penalty or penal interest will be claimed due to delay in payment on account of enforceable reason.
5. Please super scribe the envelope **“Tender for Tractor trailer and Mobile Shredder”** clearly mentioning the sender’s name and address. No correspondence shall be entertained after submission of tender. Last date for submission of seal-proof tender is **30/07/2018** during office hours (17.00 hours).
6. Along with the tender the company or party should also submit a certificate of authorized dealer/distributer in Surat district. If the product supply is found substandard, the payment will be withheld and party will have to lift the stock at his own risk and cost.
7. Lowest price shall not be the only criteria of approval of a party for supply. The comparisons will be made on similar make and models and the right to accept or partially accept or to reject any or all quotation reserved by the undersigned/ committee without assigning any reason, thereof.
8. Warranty/ guaranty/ after sale service with authorization should also be specified clearly with each of the make and model quoted for the supply. Approximate amount of future maintenance/ service contract after the expiry of warranty/ guaranty should also be specified. **The product detail and catalogue** should also be attached with quotation. All available attachment/ accessories with each of



the item should be specified and parties should also have to mention the additional accessories/ attachments along with the rate of all attachments inclusive of all taxes along with its uses and advantages.
