Terms & Conditions

- 1. Manufactures must submit certificate of registration as manufacturer along with quotation.
- 2. Authorized dealer / distributor of a company has to submit a copy of their dealership / distributorship certificate validated by the company for the Current year along with company's pricelist. In case of a chain of dealership (Area dealer / sub dealer / local dealer), all the relevant Authorization certificates up to the end supplier has to be submitted along with their business registration details.
- 3. Rates supplied in a separate sealed envelope quoted should be inclusive of all applicable Taxes and F.O.R. our Laboratories with required capacity servo voltage stabiliser at Navsari inclusive of installation, commissioning and demonstration, if any,. As per notification wide no. 47/2017 dated 14 Nov, 2017and 10/2018 dated 25 Jan, 2018— Integrated tax (Rate) by Department of Revenue, Ministry of Finance (GOI), 5% GST is applicable for government funded institute.
- 4. In case of imported instruments, suppliers will have to clear the consignment; will have to pay custom duty. Being an education institution Custom duty / excise duty exemption documents (Registration with DSIR and other related documents) will be provided. Hence, rates should be quoted keeping that in mind.
- 5. Should provide company standard warranty plus 2 years AMC free of cost including hardware change and software up gradation.
- 6. Should provide consumables with maximum possible discount (specify the amount of discount) for 5 years from date of installation of the instrument and that should be made clear at the time of quotation, if at all required.
- 7. Should make minimum 10 runs (5 samples in duplicates) on site with customer samples and show all the claims made in the catalog without discrepancy.
