



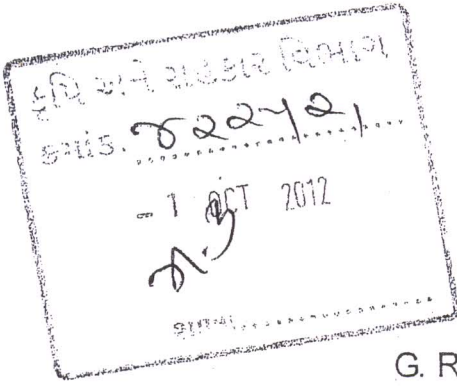

RESOLUTION :

The government has decided that linkage of full pension with 33 years of qualifying service shall be dispensed w.e.f. dated : 1-1-2006 instead of dated: 13-4-2004 and full pension at rate of 50% of last pay or average pay received during last 10 months whichever is beneficial for those who rendered 20 years or 10 years of qualifying service as case may be vide G.R., F.D. of even Number dated: 27-03-2012. As per para 3.2 of this G.R. Government servants who have opted for voluntary retirement under rule-49 of the Gujarat Civil Service (Pension) Rules, 2002 i.e. after qualifying service of 25 years and who have availed the benefit of notional increments as mentioned in sub-rule-(6) of rule-49 were required to give option within 3 months from issue of the G.R. dated 27-3-2012. The government had extended the time limit for further 3 months vide GR dated 26-6-2012.

The government has received many representations from the various pensioners' associations / individuals to extend the said time limit. Accordingly, the government is now pleased to extend the limit for further 4 months (up to dated 26-01-2013) from the date of issuance of this G.R.
