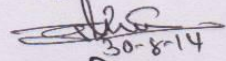

**RESOLUTION:**

Government in cognizance of the intent & desire of the former Chief Minister Shri Narendra Damordas Modi to contribute to the welfare & furtherance of the cause of education of girl children of Class IV employees of the Sachivalaya, as also of Class IV employees working outside the Sachivalaya, by donating Rupees Twenty One (21) lakhs, being emoluments received by him during his tenure as Chief Minister of the State of Gujarat between 07-10-2001 to 22-05-2014, is pleased to resolve to accept the same.

1. In pursuance thereof and to implement and further the objects of the donation, Government resolves to set up a trust and undertake the said activity in the following manner :
  - a. A trust shall be registered under the Bombay Public Trusts Act, 1950 under the name "Namo Gujarat Karmayogi Kalyan Nidhi Trust"
  - b. It shall be a permanent Government Trust
  - c. The following holders of the following Offices under the Government of Gujarat, shall in addition to their assigned responsibilities of their respective offices, be Ex-Officio Trustees of the said Trust

2. OBJECTS OF THE TRUST :

The basic object of the said Trust shall be to promote, provide and facilitate educational facilities of appropriate standards for the girl children of Class-IV employees of the Government of Gujarat working in Sachivalaya, Gandhinagar in particular, as well as of other Class IV employees working outside Sachivalaya in general, as may be deemed fit and proper to the Trust. The other objects of the said Trust, inter alia, shall be as follows :

- a. To carry out various activities for promotion and advancement of education of the girl children in various fields and faculties and at various levels of Education such as Pre-Primary, Primary, Secondary and Higher Secondary Schools and Colleges.
- b. To carry out various activities for promotion and advancement of vocational training and guidance to assist girl children having unique talents of craftsmanship, artisanship etc., so as to enable them to become self-sufficient, self-employed and self-dependent.
- c. To establish, sponsor, administer and provide funds, stipends, scholarship, study grants and also to provide financial aid for text books, reference books and other study materials to enable the deserving and/or meritorious, and needy students to pursue their studies and trainings.
- d. To provide, offer and grant, awards, prizes, trophies, fellowships, certificates, medals and other honor to recognize, encourage and



promote excellence in various faculties and fields of education and vocational trainings, arts and crafts.

- e. To take, receive, accept or otherwise acquire any gifts, donations, contributions, grants, subsidies, aids, money or property movable or immovable such as real estate, land whether by gift or otherwise or by legacy, bequeaths etc., or by any other mode from any persons, institutions, local bodies and authorities, State and Central Governments, for any of the objects of the Trust and to utilize the same as deemed fit by the Trust for the fulfilment, furtherance and accomplishment of the objects of the Trust.
- f. To invest, dispose off, transfer or otherwise deal with the assets of the Trust, in such manner as the Trust may deem fit, so as to enable it to carry on its activities and objectives with effectiveness.
- g. To do all such other ancillary, incidental or conducive activities to accomplish or attain the goals and the objects of the Trust.
- h. The Trust shall not discriminate with regard to caste, color, creed or religion and shall not be for the benefit of any particular religious community or caste and shall not be based on the aforesaid categorization and shall not involve itself in carrying on any activity for profit.

3. **SECRETARIAL ASSISTANCE & ADMINISTRATIVE SUPPORT:**

The Offices of the Trust will be located in the Welfare Branch of the General Administration Department located on the Ground Floor of Block 7, New Sachivalaya, Gandhinagar



- a. Welfare Branch of the General Administration Department will provide all secretarial assistance to the said Trust and shall deal with all issues arising from the same on behalf of Government
- b. The Sachivalaya Kalyan Samiti shall implement the resolutions passed by the Trust

#### 4. INDEMNITY OF TRUSTEES:

All action taken by the Trustees shall be, and always be, deemed to be action undertaken by them in their official capacities; and bonafide actions of the Trustees shall always be deemed to be action on behalf of government and the Trustees shall stand indemnified in their individual capacity; and all such action shall be defended by Government and its agencies, and action to sue or of being sued shall be undertaken by Government and its agencies.

#### 5. ACCOUNTS AND AUDIT:

The Trust shall maintain accounts and have audit carried out in a manner compliant to the provisions of the Bombay Public Trusts Act, 1950
