Terms and Conditions of the Tender for rate contract, 2015-16

1. Tender form has to be submitted online. Separate tender forms are to be submitted for each of the following category (**A to D**) with separate tender fees (**Rs. 1000/-** per category, Non-refundable) and earnest money deposit (**Rs. 25,000/-** per category, Refundable).

- 2. The finalized price will be valid for the entire period of rate contract i.e. up to **31-12-2016** and **F.O.R.** at Navsari and sub centers (**Appendix-A**) of Navsari Agricultural University.
- 3. The offer will be accepted from the **manufacturer** / **authorized** dealer only. In case of authorized dealers, application will be considered when they provide a letter of **original authorization** (not photocopy) from the manufacturer issued after the date of publication of the advertisement **in favour of The Director of Research**, **Navsari Agricultural University**, **Navsari**. The offer will be considered valid only when the dealer submit **manufacturer's original** (not photocopy / computer printed copy) **price list**. Price once submitted, can't be changed throughout the period of RC. Sub-dealer is not valid.
- 4. The tender form must be submitted online on or before **25.12.2015**, **17.00** hrs. A hard copy of company detail with proper seal and signature of authorized person along with three years of Income tax return (2012-13, 2013-14 and 2014-15), authentic document for address proof (like electricity bill, telephone bill, corporation tax etc), authorization letter and copy of manufacturers' original pricelist for each item / brand name (online submission of pricelist will be invalid) must be send in such a way that it must reach to Office of Director of Research and Dean, P. G. Studies, Navsari Agricultural University, Eru Char Rasta, Navsari 396 450 on or before **28.12.2015**, **17.00** hrs. Date must be clearly mentioned on fresh authorization letter. Hard copy of tender must reach to this office latest by **28.12.2015**, **17.00** hrs. Hard copy must be page numbered properly for easy and convenient screening of tender document. The envelope must be marked as "Rate Contract, 2015-16"
- 5. The above hard copy must be accompanied with Valid Registration Certificate of bidder's firm. (Shop Act Registration/Partnership deed /Memorandum of article/Registration of firm/Small scale Industry registration only) and Affidavit from the bidder that the business entity is not black listed (notarized on Rs. 100 stamp paper). Photocopy of the stamp paper will not be considered.
- 6. Brand-wise discount offered over manufacturer's price, if any, should be mentioned in column No. 5 of Appendix-A to D.
- 7. Government taxes *viz*; VAT, CST, GST etc. applicable on the price after discount as per the Government rules should be mentioned in column No. 6 and 7 of Appendix A to D (Changes in taxes are liable as per government rules). Packaging and forwarding charges, if any, should be clearly mentioned in column No. 8.
- 8. The supply must be within the delivery period mentioned in the purchase order; otherwise the consignment will be rejected.

- 9. The advance payment will not be made under any circumstances.
- 10. After finalization of rate contract, party is bound to supply any single item or all items given in the price list. Inability for the supply of goods within the stipulated period and as per the specification by the party after placement of an order will lead to forfeiture of tender deposit.
- 11. The approved parties will have to supply **60** (**sixty**) hard copies of their price-list within **15 days** from the date of issue of university order.
- 12. Penalty or penal interest will not be paid due to delay in payment on account of unavoidable reasons.
- 13. The right to accept or partially accept or to reject the offer is reserved, and cannot be challenged. Once offer rejected, there will not be any kind of reconsideration for inclusion in the rate contract.
- 14. All necessary documents will be provided for exemption of Custom / Excise duty. Suppliers will have to follow the required procedure for getting exemption of Custom / Excise duty. Suppose supplier fails to get required benefit due to his mistake/insufficiency then reimbursement of such duty will not be made. First the supplier has to pay the custom duty then the reimbursement will be made. The demurrage will not be paid in any circumstances by the university.
- 15. In case of dispute, decision of **The Executive Engineer**, **Navsari Agricultural University**, **Navsari** will be final.
- 16. The jurisdiction for any legal dispute shall be Navsari District court only.
- 17. Before submitting the application, manufacturer/distributor/dealer has to solve the territory problems. After submission of the application, such problem will not be entertained by NAU.
- 18. If any of the required information is missing, the application will be rejected straight away. If any kind of malpractice is found regarding the details submitted by the bidder is observed at any stage of procedure then the application for the rate contract will be immediately rejected and the party will be blacklisted for future endeavors.
- 19. Bidder has to keep themselves aware or updated about the changes made during the tender procedure. The changes or instructions will be available on university website (www.nau.in).
- 20. Bidder has to submit individual entry brand-wise for online submission of appendix A to D. Separate entry must be made for individual brand. If bidder use multiple brands while entering appendix details, all offers would be rejected automatically.
