Preamble:-

Finance Department, vide its letter dated 20/7/2015 referred above at (2) requested Reserve Bank of India to authorize all nationalized banks to receive all government receipts. Reserve Bank of India has accordingly given approval for all Public Sector Banks for collection of various Government receipts subject to the condition that the banks give consent letters stating that they are willing to undertake Agency business for Government of Gujarat. Accordingly, vide Resolution dated 19/1/2016 referred above at (3), **Government of Gujarat, in first phase, after receiving consent letters of the banks,** has authorized seven nationalized banks as an agency bank of RBI for collection of various receipts (tax revenue and non-tax revenue) of the State Government through e-mode and direct remittance thereof to RBI.


Resolution:

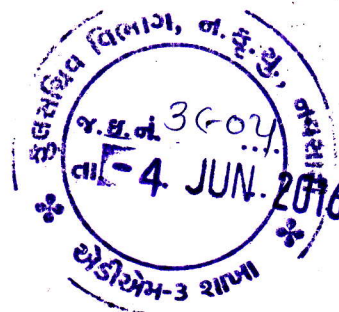
