### **Tender Notice for Purchase of Batteries**

Sealed quotations are invited by I/C Professor and Head, Food Quality Testing Laboratory, Navsari Agricultural University, Navsari from the manufacturer/authorized dealers/suppliers for the purchase of batteries (120 AH/12V SMF and 26AH/12V SMF) under buyback of older/dysfunctional batteries (No. NAU/DR/05/2018-19). ### Terms and Conditions of the Tender for purchase of SMF Battery

- 01 Bids are invited from the **manufacturer/authorized dealers/suppliers** for purchase of batteries with buyback offer for existing battery along with duly furnished information, tender fee and EMD.
- The quoted batteries should be of national and international reputed brands such as Exide, Panasonic, quanta or equivalent brand with following specification:
  - 120 AH/12V SMF Battery (Quantity; 20)
  - 26AH/12V SMF Battery (Quantity; 15)
- O3 The tender is invited with the buyback offer of the old and unserviceable/dysfunctional batteries without any warranty/ guarantee. Without quoting the buyback rate, the submitted bid should be treated as invalid and will be cancelled straightway without any further clarification. The specification of batteries under buy back is as follows:
  - 120/100 AH/12V SMF Exide Battery (Quantity; 20)
  - 18AH/12V SMF Battery (Quantity; 15)
- 04 The bidder has to visit at FQTL for onsite physical assessment of the old and unserviceable/dysfunctional batteries as well as the compatibility of the quoted batteries to the existing UPS during office hours. If the supplied batteries found incompatible or below par to its specification at the time of supply or on latter stage, the FQTL reserved right to demand a compatible version of such batteries or deal will be considered null and void and order will be cancelled.
- The bidder should not be blacklisted by any Government or Semi Government organization.
- Period of Warranty: The bidder must provide comprehensive onsite warranty for minimum 3 years from the date of installation of batteries. In case of any defect in supply or any performance related problem observed during warranty period, the bidder shall have to replace the defected battery with new battery of same technical specification without any additional cost to the purchaser. Further, any complaint shall be attended within a response time of 48 hours on 24X7 basis.
- Work specifications: The successful firm is required to dismantle the old batteries and install the new batteries. No assistance from the department will be provided in this regard. For taking away, the buyback batteries, bidder will have to inform at least two working days in advance of the intended date of lifting of the buyback items. The bidder has to bring his own vehicle for lifting the items and have to employ his own labour, bags and other items as required for packing and lifting of the materials. No assistance will be rendered in this regard by the tenderer. The bidder will be responsible for cleaning the area from where the batteries are lifted
- O8 **Tender fee:** The bidder has to submit Rs. 1500/ as non-refundable tender fee in the form of Bank Draft only, in favour of "Assistant Administrative Officer, NMCA", payable at Navsari.
- O9 Earnest Money Deposit (EMD): Bidder has to submit 3% of tender amount as EMD in the form of Bank Draft only, in favor of "Assistant Administrative Officer, NMCA", payable at Navsari which is refundable after completion of the tender procedure. However, earnest money will be forfeited in case of bidder withdraws or modifies the offer after opening the tender document.
- Security Deposit: Successful bidder has to submit 5% of purchase order as a Security Deposit in the form of Bank Draft only, in favor of "Assistant Administrative Officer, NMCA", payable at Navsari. The amount of security deposit will be refunded after three years of installation. But the security deposit will be forfeited if, Successful bidder fails to supply the items within the delivery period and/or supplier fails to comply specifications of battery and/or supplier is not providing satisfactory post sale services and support or fail to replace the defective batteries before warranty period.
- Bidders must have to quote their supply and buyback price in specified format (Appendix-I)
- The rates must be of F.O.R. to our Office including installation. The GST charges are applicable on the price after discount. No other charges will be acceptable. Being the Government organization, the applicable rate of GST would be 5%. All necessary document/certificate will be provided to the supplier or successful bidder, if necessary. However, if required certificate is not available at the time of issuing PO, The original GST rate recommended by the Central Government will be applicable.
- 13 Bidder must have to provide their details as per **Appendix-II.**
- 14 Bidder has to submit the tender documents as per the checklist (**Appendix-III**).

- 15 The bidder should submit the envelope containing signed hard copy as per checklist (**Appendix III**) along with forwarding letter (**Appendix IV**). Envelop should marked as "**Quotation for SMF Batteries**" and it must reach to the **I/C Professor and Head, N.M. College of Agriculture, Navsari Agricultural University, Navsari 396 450 (Gujarat) on or before prescribed date and time given in tender notice.** The tender received after this will not be considered.
- 16 Bids once quoted can't be changed.
- 17 The prescribed configuration is not mandatory. Higher configuration or latest model will also be permitted.
- 18 The lowest price is not the criteria and emphasis is placed on quality and specifications of the material.
- 19 The NAU may place repeat orders against the acceptance of tender within a period of validity, subject to the same terms and conditions originally provided in advertised tender and selected bidder shall accept the same.
- The supply must be within the delivery period mentioned in the purchase order; otherwise the order will be automatically cancelled. If any technical reason for delay, consent of purchaser is required.
- 21 The advance payment will not be made under any circumstances. Further, the payment of the supplies will be made after execution of the complete order.
- TDS on bill amount will be deducted as per government rules.
- There should be no discrepancy in price quoted under similar period and similar supplies at all the SAUs of Gujarat.
- Inability for the supply of goods within the stipulated period and as per the specification by the party after placement of an order will lead to forfeiture of tender deposit.
- Penalty or penal interest will not be paid due to delay in payment on account of unavoidable circumstances.
- The right to accept or partially accept or to reject the offer is reserved, and cannot be challenged.

  Once offer rejected, there will not be any kind of reconsideration for inclusion in the contract.
- 27 In case of any dispute, decision of Competent Authority, shall stand final.
- 28 The jurisdiction for any legal dispute shall be Navsari District court only.
- If any of the required information is missing, the bid will be rejected straight away. If any kind of malpractice found regarding the details submitted by the bidder at any stage of procedure, then the bid will be immediately rejected and the party will be blacklisted for future endeavours.
- Amendment of bidding documents (corrigendum), at any time prior to the deadline for submission of bids, NAU may, for any reason, whether its own initiative or in response to the clarification request by a prospective bidder, modify the bidding documents. The corrigendum will be published on website <a href="http://www.nau.in">http://www.nau.in</a> only. In order to allow prospective bidders reasonable time to take into consideration the amendments while preparing their bids, at its discretion, NAU may extend the deadline for the submission of bids.
- 31 University reserves all rights to cancel the part or whole rate contract without giving any reason
