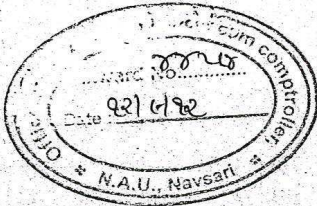
Sir,

It may please be noted that the balance release of funds during the remaining period of the financial year will be made based on the actual expenditure as will be reflected in the monthly expenditure statement and not based on the actual approved budget of the reflected. The ICAR will not be responsible in any way for any difficulty encountered by the host organizations for subsequent less release of funds and reduction of allocation in RE because of the inability on the part of the host organization to utilize on time the funds already released to them.

In view of the above, all the host organizations are requested to kindly make serious and concerted efforts in the direction of increasing the pace of expenditure vis-à-vis total utilization of funds and to ensure that there is no surrender/savings at the end of the financial year.
