## MOU FOR R & D FOR EVALUATION OF TRANSGENICS/ VARIETIES/ HYBRIDS AND AGRO PRODUCTS IN SAUs OF GUJARAT

## TERMS AND CONDITIONS

- 1) The transgenic trials will be conducted only for varieties/hybrids approved/notified by GEAC/RCGM. In case of new events, if any, permission from Licensers Company and competent authority has to be produced. If the company fails to submit permit, the trial will not be conducted and the amount forfeited.
- 2) The consent for conduct of the trial along with permit(s) should submit to the Director of Research before starting of experiment.
- 3) All the entries will be coded before sowing and evaluated with other entries with common checks.
- 4) The number of entries should not be more than three per event, per species group of a company, exceeding which will be treated as separate trial. The total number of entries of a company per crop will be restricted to six only, in maximum three trials.
- 5) H X B entries will be evaluated in separate trial.
- 6) In case of Bt varietal evaluation, conventional non Bt and Bt checks will be taken as laid out by DBT/ ICAR.
- 7) The material to be evaluated along with checks shall have to be supplied for a cost by the concerned company.
- 8) The total number of treatments (in case of agronomy/entomology/physiology evaluation) per trial should not exceed 8 with 3 replications. If the number of treatments exceeds 8, each additional treatment but not exceeding 10(ten) will be charged @ Rs.20,000/- + overhead charges, as applicable.
- 9) Fibre quality will be analyzed on chargeable basis by CIRCOT. Remittance for the same shall have to be made directly in the name of <u>"Director, CIRCOT", payable at Mumbai</u> and sent to Scientist in charge, CIRCOT, Athwa Farm, Surat-395 007 under intimation to Research Scientist (Cotton), Surat.
- i. Relevant technical information /data for toxicity environmental safety if applicable must be provided by the company.
- ii. Residue and food quality character will be analyzed on chargeable basis and same will be made by concerned company.
- 10) The university shall not share the information / results of the trial to any other individual / agencies except for official use.
- 11) The university will have full right to utilize the data for research purpose.

12) The total charges for one year/trial/location for the current season will be Rs.4,00,000/- as per details given hereunder. (FOR EXAMPLE)

- 14) Other terms and Conditions

  - b. This university shall have full right to utilize unspent balance, if any, for the research work or any other purpose at its discretion. For this no permission from the financing agency will be required. Such consent deemed to have been given on approval of the project.
  - c. Due to natural calamities or other reasons beyond our control, if the experiment is not successful or fail, the university shall not be responsible and balance amount if any shall not be reimbursed/ returned to the party/ agency or carried forward for the same purpose.
  - d. The university does not hold any responsibility or liability for reproduction of results or injury thereto or products there of.
- 15) Government levies/taxes, if any, existing or future shall be sole responsibility of party/ company.
- 16) Not withstanding with any/many of the above clauses, the terms and conditions are subject to change without any prior notice and shall be binding on the party.
